#### **Aims**

At The Corbet School, our intent for Personal, Social, Health, and Economic Education (PSHEE) and Relationships and Sex Education (RSE) is to deliver a comprehensive programme that enables our learners to become responsible and confident citizens while developing their emotional, mental, and physical well-being. We aim to embody our three core principles of Ready, Respectful, Responsible and prioritize the acquisition of knowledge, skills, and values to help our learners establish healthy relationships, make informed and responsible choices, and promote their own and others' well-being.

Our PSHEE and RSE curriculum is designed to improve our learners' resilience, confidence, empathy, and self-respect, enabling them to manage their own risks and make informed choices.

We aim to prepare pupils for puberty and give them an understanding of sexual development and the importance of health and hygiene. To create a positive culture around issues of sexuality and relationships and teach pupils the correct vocabulary to describe themselves and their bodies.

## **Statutory Requirements**

Our PSHEE and RSE curriculum is grounded in the statutory guidance and principles, including the Department for Education's guidance on Relationships and Sex Education. It follows a spiral approach that ensures continuity and progression across all year groups. We use a variety of teaching and learning strategies, including group discussions, interactive presentations, and role-plays, to engage our learners and promote their active participation in their learning.

As a secondary academy, we must provide RSE to all pupils under section 34 of the <u>Children and Social Work Act 2017</u>. Furthermore, <u>Relationships and RSE Statutory Guidance 2019</u>, has enhanced the presence of RSE in Secondary Curricular.

In teaching RSE, we're required by our funding agreements to have regard to <u>guidance</u> issued by the Secretary of State, as outlined in section 403 of the <u>Education Act 1996</u>.

We also have regard to legal duties set out in:

- Sections 406 and 407 of the Education Act 1996
- Part 6, chapter 1 of the Equality Act 2010
- The Public Sector Equality Duty (as set out in section 149 of the Equality Act 2010). This duty requires public bodies to have due regard to the need to eliminate discrimination, advance equality of opportunity and foster good relations between different people when carrying out their activities.

At The Corbet School we teach RSE as set out in this policy.

## **Policy development**

This policy has been developed in consultation with staff, pupils, and parents. The consultation and policy development process involved the following steps:

- 1. Review a member of staff or working group pulled together all relevant information including relevant national and local guidance.
- 2. Staff consultation all school staff were given some CPD and a chance to voice their opinion during the PSHEE review.
- 3. Pupil consultation we investigated what exactly pupils want from their RSE through pupil voice.
- 4. Ratification once amendments were made, the policy was shared with governors and ratified.

#### **Definition**

RSE is about the emotional, social, and cultural development of pupils, and involves learning about relationships, sexual health, sexuality, healthy lifestyles, diversity, and personal identity.

RSE involves a combination of sharing information and exploring issues and values.

RSE is not about the promotion of sexual activity.

#### Curriculum

Our programme covers a range of topics, including mental health and emotional well-being, relationships, sexual orientation, consent and boundaries, healthy lifestyles, drug and alcohol education, financial education, online safety, and careers education. Delivery is flexible to ensure that discussions are timely and sensitive to learners' specific needs.

We ensure that staff delivering the PSHEE and RSE curriculum are well-trained, confident, and competent. Our staff regularly receive up-to-date training and support to ensure they feel equipped to teach appropriate, relevant, and inclusive lessons. We collaborate closely with parents, carers, and outside agencies, such as the School Nurse and Sexual Health Clinic, to ensure that our learners have access to appropriate support and advice.

Our RSE curriculum is set out as per Appendix 1, but we may need to adapt it as and when necessary.

We have developed the curriculum in consultation with parents, pupils and staff, and considering the age, developmental stage, needs and feelings of our pupils. If pupils ask questions outside the scope of this policy, teachers will respond in an appropriate manner so that pupils are fully informed and don't seek answers online.

## **Delivery of RSE**

RSE is taught within the Personal, Social, Health and Economic Education (PSHEE) curriculum. Biological aspects of RSE are taught within the science curriculum, and other aspects are included in religious education (RE).

Year 7 and 8 are taught RSE through their weekly PSHEE lesson.

Year 9 participate in a number of PSHEE Focus days across the school year.

Year 10 and 11 are taught RSE through their weekly PSHEE lesson.

RSE focuses on giving young people the information they need to help them develop healthy, nurturing relationships of all kinds including:

- Families
- Respectful relationships, including friendships
- Online and media
- Being safe
- Intimate and sexual relationships, including sexual health

These areas of learning are taught within the context of family life, taking care to make sure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBT parents, families headed by grandparents, adoptive parents and foster parents/carers, amongst other structures), along with reflecting sensitively that some children may have a different structure of support around them (for example, looked-after children or young carers).

We will also be mindful of the law and legal requirements, taking care not to condone or encourage illegal political activity, such as violent action against people, criminal damage to property, hate crime, terrorism or the illegal use of drugs.

Across all Key Stages, pupils will be supported with developing the following skills:

- Communication, including how to manage changing relationships and emotions.
- Recognising and assessing potential risks
- Assertiveness
- Seeking help and support when required
- Informed decision-making
- Self-respect and empathy for others
- Recognising and maximising a healthy lifestyle
- Managing conflict
- Discussion and group work

These skills are taught within the context of family life.

# **Inclusivity**

All aspects of RSE and PSHEE are delivered in an inclusive manner so that they:

- consider how a diverse range of students can relate to them.
- are sensitive to all pupils' experiences.
- makes pupils feel:
  - o safe and supported.
  - o able to engage with the key messages.

#### We will also:

- Make sure that pupils learn about these topics in an environment that's appropriate for them, for example in:
  - A whole-class setting
  - o Small groups or targeted sessions
  - o 1-to-1 discussions
  - Digital formats
- Give careful consideration to the level of differentiation needed

#### Use of resources

We will consider whether any resources we plan to use:

- o Are aligned with the teaching requirements set out in the statutory RSE guidance
- Would support pupils in applying their knowledge in different contexts and settings
- o Are age-appropriate, given the age, developmental stage and background of our pupils
- Are evidence-based and contain robust facts and statistics
- o Fit into our curriculum plan
- o Are from credible sources
- Are compatible with effective teaching approaches
- Are sensitive to pupils' experiences and won't provoke distress

# Use of external organisations and materials

We will make sure that an agency and any materials used are appropriate and in line with our legal duties around political impartiality.

The school remains responsible for what is said to pupils. This includes making sure that any speakers, tools and resources used don't undermine the fundamental British values of democracy, the rule of law, individual liberty, and mutual respect and tolerance of those with different faiths and beliefs.

#### We will:

- Make appropriate checks and engage with external agencies to make sure that their approach to teaching about RSE is balanced, and it and the resources they intend to use:
  - o Are age-appropriate
  - Are in line with pupils' developmental stage
  - o Comply with:
    - This policy
    - The Teachers' Standards
    - The Equality Act 2010
    - The <u>Human Rights Act 1998</u>
    - The Education Act 1996
- Only work with external agencies where we have full confidence in the agency, its approach and the resources it uses
- Make sure that any speakers and resources meet the intended outcome of the relevant part of the curriculum
- Review any case study materials and look for feedback from other people the agency has worked with
- Be clear on:
  - What they're going to say
  - o Their position on the issues to be discussed
- Ask to see in advance any materials that the agency may use
- Know the named individuals who will be there, and follow our usual safeguarding procedures for these people
- Conduct a basic online search and address anything that may be of concern to us, or to parents and carers
- Check the agency's protocol for taking pictures or using any personal data they might get from a session
- Remind teachers that they can say "no" or, in extreme cases, stop a session
- Make sure that the teacher is in the room during any sessions with external speakers

#### We won't, under any circumstances:

- Work with external agencies that take or promote extreme political positions
- Use materials produced by such agencies, even if the material itself is not extreme

## Roles and responsibilities

#### The Governing Body

The governing board will approve the RSE/PSHEE policy and hold the headteacher to account for its implementation.

#### The Headteacher

The Headteacher is responsible for ensuring that RSE is taught consistently across the school, and for managing requests to withdraw pupils from [non-statutory] components of RSE.

#### **Staff**

Staff are responsible for:

- Delivering RSE in a sensitive way
- Modelling positive attitudes to RSE
- Monitoring progress
- Responding to the needs of individual pupils
- Responding appropriately to pupils whose parents wish them to be withdrawn from the [non-statutory] components of RSE.

Staff do not have the right to opt out of teaching RSE. Staff who have concerns about teaching RSE are encouraged to discuss this with the headteacher.

#### **Pupils**

Pupils are expected to engage fully in RSE and, when discussing issues related to RSE, treat others with respect and sensitivity.

# Parents' right to withdraw.

At The Corbet School, we emphatically believe that Relationships and Sex Education (RSE) is an essential part of our pupils' education. Through a clear framework of delivering high-quality RSE, we ensure that pupils are equipped with accurate information, skills, and values to empower them to build healthy and positive relationships throughout their lives.

Parents have the right to withdraw their children from the non-statutory/non-science components of sex education within RSE up to and until 3 terms before the child turns 16. After this point, if the child wishes to receive sex education rather than being withdrawn, the school will arrange this.

Requests for withdrawal should be put in writing and addressed to the headteacher.

A copy of withdrawal requests will be placed in the pupil's educational record. The headteacher will discuss the request with parents and take appropriate action.

Alternative work will be given to pupils who are withdrawn from RSE.

# **Training**

Staff are trained on the delivery of RSE as part of their induction and it is included in our continuing professional development calendar.

Visitors from outside the school, such as nurses or sexual health professionals, will also be invited to provide support and training to staff teaching RSE.

# **Monitoring Arrangements**

The delivery of RSE/PSHEE is monitored by the Curriculum Lead using the current monitoring systems at The Corbet School. This may include aspects of Pupil/Teacher/Parent Voice, learning walks, book reviews and focus groups.

Pupils' development in RSE is monitored by class teachers as part of our internal assessment systems.

This policy will be reviewed by the curriculum lead.

At every review, the policy will be approved by the Senior Leadership Team and the governing body (curriculum committee).
